NEF FUNDING AUTUMN TERM 2021

Dear Parent,

Your child will be eligible for Nursery Education Funding from the start of the term following his/her 3rd birthday. All children with birthdays between 1st April 2018 and 31st August 2018 therefore become eligible for this funding from Autumn Term 2021 onwards.

The funding allows parents to access up to 570 hours of universal free entitlement each year and working parents may also be eligible for the extended free entitlement which is for up to 1,140 hours each year. At Little Elms the free entitlement is stretched over all 52 weeks of the year as noted in the table below:

Universal Entitlement (15 hours)	Extended Entitlement (30 hours)	
570 hours funding stretched to 10.95 hours per week for 52 weeks	1,140 hours funding stretched to 21.90 hours per week for 52 weeks	15/30 HOURS

IMPORTANT NOTICE

If your child leaves the nursery during a stretch period (i.e. each stretch period lasts 1 year and is from the start date of your funding), then a reconciliation will be carried out on your account to ensure the hours given to you agrees to the council funding received, this may result in an additional charge or a credit being applied to your account.

If you are eligible you will be given an 11-digit eligibility code beginning with 5000 by HMRC. This code will be valid for three months after which time you will be required to re-confirm your eligibility (you can expect to receive reminders from HMRC around the time that your code validity expires). It is your responsibility to make sure your code is reconfirmed on time. The nursery does not have access or authorisation to do this.

In order that your claim for universal and/or extended free entitlement can be processed and your free entitlement allocated to your fees for September 2021 you need to return the following documents to us by 7th August 2021

- Completed and signed parental declaration form;
- Your HMRC eligibility code if claiming extended hours
- Copy of your child's birth certificate;
- Copy of proof of address e.g. recent utility bill;
- Completed child characteristics/ethnicity code

PLEASE COMPLETE ALL HIGHLIGHTED SECTIONS, YOUR FUNDING APPLICATION COULD BE REJECTED IF THE INFORMATION REQUESTED IS NOT GIVEN. RETURN THIS CONTRACT TO YOUR NURSERY MANAGER WHO WILL NEED TO CHECK AND SIGN IT.

You may have been claiming funding in previous terms but please note that if you are now eligible for additional hours funding and/or your child increases or decreases sessions then you must complete a new parental declaration form in order that we can claim the adjusted amount from the Council.

We have been advised by the Council that there is an <u>absolute cut-off date of 31st August 2021</u> for obtaining or re-confirming the eligibility codes. If you <u>do not</u> obtain a valid code by this date then you <u>will not</u> be awarded funding for Autumn Term 2021. You will have to wait until the next term. Please therefore ensure that you remember to do this.

Allocation of funding:

Our invoices for <u>Pre-School children that are eligible for funding</u> are calculated on an actual session basis. We allocate specific hours on your weekly booking line to be free hours and charge you a total net fee including charged hours and free hours, this is as recommended by the Council Early Years.

At Little Elms we have decided to allocate the maximum of 570 hours universal funding at 10.95 hours per week for 52 weeks of the year. For those eligible for the additional hours funding, we have decided to allocate the maximum of 1,140 hours funding at 21.90 hours per week for 52 weeks of the year.

Please note that there are restrictions as per the Council Early Years:

- 1 A maximum of 10 hours in any one day,
- 2 Full free entitlement of 10.95 hours over a minimum of 2 days may be claimed.
